



# PRIVACY NOTICE FOR PARENTS AND CARERS:

## USE OF YOUR CHILD'S PERSONAL DATA

We, Purley Oaks Primary School, are a data controller for the purposes of the General Data Protection Regulation (GDPR). We collect and use personal data relating to pupils and their families and may also receive information regarding them from their previous school, Local Authority or Department for Education.

SCC DPO Services are the Data Protection Officer. Their role is to oversee and monitor the role of the school's data protection procedures and to ensure they are compliant with the GDPR.

### Why we collect and use this information:

- Support your child's learning
- Monitor and report on progress
- Provide appropriate pastoral care
- Assess the quality of our services
- To comply with the law regarding data sharing

### The categories of pupil information that we collect, hold and share include:

- Personal information (contact details, including name, address, telephone number)
- Unique pupil number
- National curriculum assessment results
- Attendance information, such as sessions attended, number of absences and absence reasons
- Personal characteristics, such as ethnicity, language, nationality, country of birth
- Other categories of information include: free school meal eligibility, any special educational needs that your child may have, relevant medical information and exclusions/behavioural information

### The lawful basis on which we use this information

We will not give information about you or your child to anyone without your consent unless the law and our policies allow us to. We collect and use personal data in order to meet legal requirements and legitimate interests set out in the General Data Protection Regulations (GDPR) and UK Law, including those in relation to the following:

- Article 6 and Article 9 of the GDPR

- Education Act 1996
- Section 3 of The Education (Information About Individual Pupils) (England) Regulations 2013

### Collecting pupil data

Whilst the majority of pupil data you provide to us is mandatory, some of it is provided to us on a voluntary basis. In order to comply with the General Data Protection, we will inform you whether you are required to provide certain pupil information to us or if you have a choice in this.

If it is mandatory, we will explain the possible consequences of not complying. Where consent is required, the school will provide you with specific and explicit information with regard to the reasons why the data is collected and how the data is used.

### Storing Pupil Data

Personal data relating to pupils at Purley Oaks Primary School, Nursery and Children's Centre and their families is stored in line with the school's GDPR compliant Data Protection Policy. In accordance with the GDPR, the school does not store personal data indefinitely; data is only stored for as long as is necessary to complete the task for which it was originally collected.

### Who we share pupil information with

We routinely share pupil information with:

- Our local authority (LA) – to meet our legal obligations to share certain information with it, such as safeguarding concerns and exclusions
- The Department for Education (DfE)
- Central and local government
- Schools that the pupils attend after leaving us
- Health and social welfare organisations such as the school nurse team
- Our health authority – Public Health England
- Our regulator – Ofsted
- The pupil's family and representatives
- Examining and professional bodies
- Suppliers and service providers – to enable them to provide the service we have contracted them for including:
  - Our IT provider – *Octavo*
  - Our broadband provider – *London Grid for Learning*
  - Our communications platform - *Weduc*

- Our online payments provider – *sQuid*
- Our payment system – *sQuid*
- Our parents evening booking system – *School Cloud Systems*
- Our uniform supplier – *Mapac*
- Our after school/holiday club – *Holiplay*
- Our photographer – *Stanley Baker Studios*
- Our free school milk supplier – *Cool Milk*
- Our online learning platform – *Google Classroom*
- Our online document platform – *Google Drive*
- Our online curriculum softwares – *Times Table Rockstars, Juniper Education, Pixl Club, White Rose, Phoenix Software, Reading Cloud*
- Our staff and visitor registration system – *InVentry*
- Our after school external club providers – *Twizzlers, Le Club Francais, Skills*

### **Why we share pupil information**

We do not share information about our pupils with anyone without consent, unless the law and our policies allow us to do so.

We share pupils' data with the Department for Education (DfE) on a statutory basis. This data sharing underpins school funding and educational policy and monitoring.

We are required to share information about our pupils with the Local Authority (LA) and the Department for Education (DfE) under section 3 of the Education (Information about Individual Pupils) (England) Regulations 2013.

### **The National Pupil Database (NPD)**

The NPD is owned and managed by the DfE and contains information about pupils in schools in England. It provides invaluable evidence on educational performance to inform independent research, as well as studies commissioned by the Department. It is held in electronic format for statistical purposes. This information is securely collected from a range of sources including schools, local authorities and awarding bodies.

We are required by law, to provide information about our pupils to the DfE as part of statutory data collections such as the school census and early years' census. Some of this information is then stored in the NPD. The law that allows this is the Education (Information About Individual Pupils) (England) Regulations 2013.

The Department may share information about our pupils from the NPD with third parties who promote the education or well-being of children in England by:

- conducting research or analysis
- producing statistics
- providing information, advice or guidance

The Department has robust processes in place to ensure the confidentiality of our data is maintained and there are stringent controls in place regarding access and use of the data. Decisions on whether DfE releases data to third parties are subject to a strict approval process and based on a detailed assessment of:

- who is requesting the data
- the purpose for which it is required
- the level and sensitivity of data requested: and
- the arrangements in place to store and handle the data

To be granted access to pupil information, organisations must comply with strict terms and conditions covering the confidentiality and handling of the data, security arrangements and retention and use of the data.

### **Requesting Access to your personal data**

Under data protection legislation, parents and pupils have the right to request access to information about them that we hold. ### **What are your rights?**

You have the right to:

- Object to processing of personal data that is likely to cause, or is causing, damage or distress
- Prevent processing for the purpose of direct marketing
- Object to decisions being taken by automated means
- In certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed;
- To withdraw your consent at any time, where the processing of data is based on your consent
- Claim compensation for damages caused by a breach of the Data Protection regulations
